 - ii. “Climate Action Museum Guided Tour” 2/16th & 3/15th @2pm - Liz W-Chase Two dates set-up for our community, there are sign-up sheets. Preferred to preregister. Participants may travel there via train. Option for vegan/veggie restaurant. Two people leading tour, an architect and former mayor both on board.
 - iii. “Air Pollution and Your Health” with C. Patricia Macias, MD, MPH 2/24th @ 1:00pm - Liz Dr. Macias works with the International Union Against Tuberculous and Lung Disease - A partner organization of the World Health Organization and has lived in others countries. EWC known for 30 years, outstanding person to speak on topic. Trying out later time for winter presentation.
 - iv. “April Showers bring Native Flowers” - Discussion From last month that could be grouped together for event, Paint and Sip Rain Barrels and Green Neighbor Guide, Electric Lawn Care equipment. EWC-Group purchasing equipment. LK-Getting gas out of the household. What does event looks like? Seeds - Particulate matter device to borrow from EPA. Business cards, not out of budget. Shirts for GROW. 5 rain barrels to include seeds. Paint supplies quote. ES-When can we get rain barrels. Have AC connect with MWRD for presentation. NM-Seed quote.
 - v. “Reuse A Palooza” confirmation of 9/14th and 15th dates - LeeAnn Notice to go out in next months’ newsletter for volunteers to market and map. LAK to set up. Prairie Fest that weekend of 14/15th. LP-Modchester with Prairie Fest move to weekend before on 7th. Move to following weekend 21/22nd for Reuse-a-palooza pending confirmation.
 - vi. “EV Car Show” with “Concert in the Park” August date confirmation - Liz Date confirmation with Concert At the Park. Find out what bands are playing and have event with newest music for the future of cars. Start recruiting cars for event. ES-New committee for Events, need to bring to them. At Mayfair Park.
