## **CALL TO ORDER:**

The meeting was called to order at 6:10 pm. followed by the Pledge of Allegiance. Responding present to roll call were Commission Chair Tom McCarthy, Commission Secretary Brian Kuratko and Commissioner James O'Shea. Also present was Commission Assistant Mary Detente.

# APPROVAL OF MINUTES:

Commissioner O'Shea made a motion, seconded by Commissioner Kuratko, to approve the Regular Meeting Minutes of June 5, 2019. Minutes were approved.

## **NEW BUSINESS:**

There was no new business to discuss.

### **OLD BUSINESS:**

The first item under Old Business was the Annual Report. Commissioner McCarthy stated he would have the report ready for presentation at the August Meeting.

The discussion then moved onto police department vacancy and hiring status. Police candidate Michael Goorsky will take the POWER test on August 13 and start the academy August 26, 2019.

Commissioner McCarthy then discussed Entry Level Police Testing. The written test was held on June 15, 2019. There were 51 candidates who passed the written test. Interviews were conducted on July 9, 10 and 11, 2019. There are 30 candidates who have passed both the written and oral interviews. These 30 candidates will be placed on the Initial Eligibility List and will be notified by IO Solutions that they have 10 days to request for preference points and how to go about requesting for these points. Letters will go out to candidates who did not receive a passing score on the interview and also to candidates who did not attend their interview explaining they will not be moving on in the testing process. At this time the Initial Eligibility List was presented. A motion was made by Commissioner Kuratko and was seconded by Commissioner O'Shea to approve the Initial Eligibility List for Police Officer. Motion passed unanimously and was approved.
