# **GROW Ecological Commission Regular Meeting**

- 4. Roll Call Quorum established 5 commissioners present
- 5. Review of Minutes
  - a. Approval of 5-4-2023 minutes deferred until July no vote
- 6. 6:40 Presentation
  - a. International Pure Water Filter Kenny Valentino (5 min.)
    - i. Works with municipalities only, started in IL. Stated that our water is some of the worst water in Midwest next to MI. Bring a short, intermediate, and long term solution for water remediation. Developed in Israel, team here to spread the word. Technology different using nano technology, not carbon filter or reverse osmosis. Provide units and year worth of cartridges, one cartridge last three months. Gave presentation at South Suburban Mayors' Conference. Asked how do we fund a project like this with GROW recommendations?

### b. Q & A

- LWC Discussed that the Village of Westchester is currently in full compliance with the Chicago Department of Water Management and IL EPA water standards.
- ii. KV stated that Water Quality Filters manufactured in Chicago and recycled in Chicago and stated we could visit the recycling center. Stated that another facility in South Elgin is planned and was funded with minority business venture grant..
- iii. KV stated IPW only has the one device on the US market and only in a few local Chicago Area municipalities Elmwood Park and Leyden Township, with plans underway in Cicero, Lyons and Berwyn.
- iv. Current device is a plastic water picture with replaceable filters. Representative quoted the Village \$300,000 for one year for 1,000 households. Was unable to speak to the number of gallons for which each filter would effectively filter. Stated "a family of four." Stated cost for use is 80 cents a day per person. Subscription \$32 bucks per cartridge. Stated municipalities fund acquisition through lead remediation funds put aside, reallocation of funds, based on water revenue increase or state funded grants.
- v. Discussed lab results of filter effectiveness related to the reports produced to the vendor from a water testing laboratory in WI. One set of results were presented for evaluation per panel of analytics (i.e. VOCs...), data presented was 2-3 years old, and did not contain all the assays the materials the vendor claimed the device effectively filters.
- vi. Was asked to describe quality control, quality assurance, and proficiency testing process. Quality Assurance testing how often? Stated testing all along, latest tests based on legislation passed by state.
- vii. When asked about there not being US patent information for International Pure Water, stated device has US patent under inventor's name, and they are in midst of rebranding. Asked about ANSI certification with NPS or WQA. Stated not yet. Stated beta of new version of the device will be coming out July 15th and will have certification.
- viii. Stated process for recycling cartridge is negotiable based on terms of agreement. Suggested a collection bin in Village Hall.
- ix. IPW has future plans to develop and market a tap connected to a sink filter assembly. Currently does not have a whole house filtration system.

Maybe an in-house program where village could bulk buy for dunks at reduced cost.
