# MEETING MINUTES FIRE AND POLICE COMMISSION MEETING October 7, 2020

## **CALL TO ORDER:**

The meeting was called to order at 6:05 pm. followed by the Pledge of Allegiance. Responding present to roll call were Commission Chair McCarthy, Commissioner Pedersen and Commissioner O'Shea

#### **APPROVAL OF MINUTES:**

# **NEW BUSINESS:**

Commissioner McCarthy discussed the resignation of Firefighter Timothy, saying he took a position in Carol Stream which leaves a vacancy in the fire department. Village Manager Nosek approved the Commission to fill this vacancy. The next candidates being processed for hire are Kyle Piotrowski and Matthew Bohnen. Both have been scheduled for polygraphs and background checks. When background investigations and polygraph ults are received the Commission will schedule 2<sup>nd</sup> interview dates for both.

#### **OLD BUSINESS:**

Entry Level Firefighter was the first item of old business to discuss. Commissioner McCarthy explained the 2 candidates; Kate O'Brien and Kyle Wilson have been issued start dates. Both candidates will have their first day as probationary firefighters on October 12, 2020.

The Police Sergeant Promotional Exam was then discussed. Commissioner Pedersen explained the exam is all planned and ready to go. The written exam will be on November 7<sup>th</sup> in the Village Hall Community Room and will be administered by IO Solutions. Deputy Chief O'Hagan has worked with Dan from P4 Global to set up a schedule for the Assessment Center that will accommodate the officers work schedule. The Assessment will take place on November 10, 11 and 12<sup>th</sup>, in the Village Hall Court Room.
