i. Barry spoke with the district Superintendent about movie nights at school for extra credit. Because the school does not offer an extra credit policy, the Superintendent suggested a summer movie night. Walt asked how they would meet the governor's mandate to teach climate change? Evie suggested that Walt engage as a resident since the village does not have jurisdiction over the school. The Sup liked the children's books sent over and noted that the curriculum is set and there is overlap. The district is interested in events like Arbor Day and Air Quality Awareness Week with the village. Open to collaboration.

c. IL Anti-Idling Statutes/Ordinance

i. Jim, Barry, Annie at Village, who met with the police department. The department is aware of the new statute, violations are not common, but they are acted upon. Asked that citizens call the police. ACTION: GROW to make a newsletter blurb. Liz has an Idolbox toolkit.

d. Sustainable Purchasing Statement

i. Submitted to village administration. The Village Board also discussing procurement procedures; this will be discussed within the larger update.

e. Community Solar Clearinghouse Solution

i. Postcard was mailed, on Facebook, website. Liz thanked Evie, Annie, and Barry for moving this forward.

H. Old Business (30 min)

- a. GRC / C-4 Discussion Special Meeting Liz (3 min)
 - a. Lee the document is a powerful tool and has a strong structure related to municipal operations. We need to meet with Village staff to lay out the easy wins that could be implemented by people being aware of them. Believes that GRC is more clear than C4 for a roadmap forward.
 - b. Kari big topic, need a sperate meeting to move forward since there are so many directions to go, need to summarize so not to duplicate efforts.
 - c. Walt There are other municipalities that have implemented these, can we understand what has been easily done?
 - d. Nikki Should have a sub-committee to put a roadmap together for how we engage in this content. C-4 is particularly compelling because it is a local government similar to Westchester.
 - e. Liz, there are overlaps between GRC and C-4. One of the structures of C4 has teams around each objective. That structure could potentially help engage residents (such as interacting with the school district).
 - f. Evie Subcommittees do not need public meetings.
 - g. Lee We use the GRC to develop a plan, and then leverage C4 for resources.
 - h. ACTION: Nikki and Evie discussed whether residents can be on a subcommittee. She will investigate it. We could have multiple subcommittees and then hold a special meeting to move forward. Propose we start with the four areas that we've worked on to have subcommittess: climate, energy, municipal operations, water.

b. Purple Air Monitor – Liz

- i. Liz personally acquired a Purple Air Monitor for community education.
- **c.** GROW Holiday Gathering Walt

- i. Would like to have an event with the Board of Trustees to build rapport and get them to events. Evie suggested we could do it personally but not discuss business. She also suggested sending personal emails.

 - i. October event debriefs (5 min)
 - 1. Pumpkin Smash did well! Next year November 8.
 - 2. Tree Walk Well attended; the walk was not what people anticipated. Public comments noted that the walk felt political and complaint, it detracted a lot for what people could take away. Suggested that we vet the speakers or choose ones that will represent the village.
 - ii. Upcoming event support needs (5 min)
 - 1. Food Pantry table on November 17th, Walt will be there. Everyone to send materials to Walt for tabling.

- a. Residential Outreach for Illinois Solar for All
 - 1. The program for income-eligible residents. Since we are rolling out a community solar clearing house and wanted to start a dual track for reaching out, has the village identified income-eligible residents? Annie said there are no applicants for water grants yet, but she cannot share the info but can add it to the website. Discussion of having "open office hours" where Liz can assist residents for applying for Illinois Solar for All, or include her email address so she could meet them at the Village.

J. Comments (5 min)

- a. Commission Comments
 - 1. Lee Are there any updates for the Village Comprehensive Plan? Evie said they have looked at the old plans and nothing has changed. The other Commissions are working on some of those items.
 - 2. Nikki What will happen with the new federal admin regarding solar? Liz federal tax credit might change, it has fluctuated. There is a state renewable energy tax credit. Lee thinks the states will take more action, but funding was difficult to get.
 - 3. Liz Westchester now has 119 electric vehicles. Growth is impressive. Evie suggested that these could be fun facts for the Village newsletters. Calendar will move one week on holiday dates for January, July, December moving back a week.
