MEETING MINUTES FIRE AND POLICE COMMISSION MEETING January 4, 2023

CALL TO ORDER:

The meeting was called to order at 5:37pm followed by the Pledge of Allegiance. Responding present to roll call were Commission Chair McCarthy, Commissioner Pedersen, Police Chief Babich and Commission Attorney Jurusik. Commissioner O'Shea was absent.

APPROVAL OF MINUTES:

Commissioner Pedersen made a motion, seconded by Commissioner McCarthy, to approve the Regular Meeting Minutes of November 30, 2022, and the Special Meeting Minutes of December 21, 2022. The motion passed and the minutes were approved.

NEW BUSINESS:

The only item of new business to discuss was the review of Lateral Transfer Police Officer requirements. Commissioner McCarthy explained there was communication from the Village Board to review requirements and age limitations for lateral officer. Commission Attorney Jurusik explained that due to the Village not being a Home Rule town, no maximum age limit can be set. This would be considered discrimination. Commission Attorney recommended the BFPC attend a Village Board meeting for further clarification on their request.

All items of old business were tabled to adjourn to executive session for police officer interviews.
