- a. Selection of the two Grand Marshalls for the Fourth of July
  - Mary Gish and Richard Ciroca were confirmed as Grand Marshalls
- b. Parade as well as a "Court of Honour" (tabled from last meeting)
  - After some discussion about whether the Court would be recognized at the parade, it was determined in event subcommittee for Party in the Park (and potentially mentioned at the previous meeting) that recognition of all long-time residents would take place at Party in the Park as opposed to having them ride in cars at the parade.
  - Acting Chair Ernst asked if all the participants met the requirements.
     Administrative Services Coordinator Canavan mentioned that almost all interested parties have resided in Westchester for at least 50 years.
  - Trustee Liaison Slavic suggested that an announcement be made at the event for any residents that did not receive the invitation to come to the stage and be recognized, which was met with approval.
  - Commissioner Roback asked if, in the event of inclement weather, residents could receive a certificate. Commissioner Alexander confirmed that this had been discussed in subcommittee and was in the works.
  - Some discussion followed regarding which space would be used, with the general consensus being that some space near the main stage would be designated for this purpose.
- c. Event subcommittee updates
  - Commissioner Helgesen requested that Committee members interview some people they know for Voices of Westchester. Chairperson Roback added additional details about making recordings. He also mentioned that interviews should be conducted sometime before the end of the year.
  - Commissioner Alexander called for volunteers for Party in the Park and shared a list of events and activities.
  - Commissioner Helgesen requested that more advertising be done to generate interest in the project. Trustee Slavic requested more details. Commissioner Roback offered to create a graphic for advertising and an interview card so everyone will have a script for conducting short-form interviews.
  - Commissioner Ladas shared that arrangements for setting up the Wine and Cheese fundraiser have mostly been finalized. Patricia from the Prairie House said she would be available during the event to give tours and answer questions.
  - Commissioner Helgesen asked if the video can be sold as a fundraising item. Commissioner Alexander discussed crediting photos and that this is a possibility going forward, but did not have any further update at this time.
  - Commissioner Ladas asked how many people have signed up for the Wine and Cheese event, and Administrative Services Coordinator Canavan said that there were two sessions recommended by Patricia in order to have more than 50 persons (capacity of the building), but that no one had purchased tickets for the late afternoon session, so they had decided to cancel that session. Commissioner Helgesen asserted that this should not have decided without consulting the Committee. Trustee Slavic

stated that this was about making more money at the event, but that she was not involved in the decision. Canavan stated that she was unaware that members of the Committee did not know about two separate sessions since it was advertised on the website, but nothing was purposely altered (the sessions decision was recommended by Patricia Reeves as the host). Further discussion of event minutiae continued.
