b. Illinois Alliance for Clean Transportation – Liz attended and networked to meet professionals in the clean transportation space. She learned that ChargePoint partners

with gas stations and other entities interested in installing EV chargers. She met the ComEd Fleet Manager, Les Paul who gave a presentation on ComEd's Fleet. By the end of 2025, 30% of their vehicle fleet will be electrified in some form (fully electric, hybrid or having anti-idling technology). When asked if he could provide one of ComEd's vehicles for the Village's parade, he said yes. Also, met Pete Probst of Indigenous Energy/B20 Club who provides free consultations to fleets to ensure they are successful using biodiesel. He lives in Brookfield and would assist our Village.
