## 5. Active Agenda

## A. Approval of the following minutes-

**Minutes of April 27<sup>th</sup>, 2015-** A motion was made by Bruce Horek to approve the minutes of the May 11th 2015 meeting, second by Allison Muzal; the minutes were unanimously approved.

B. Swearing in of EDC committee by Village President, Sam Pulia of Pastor Joe Mills, Allison Muzal, Bruce Horek. Lori-Jo Fergle and Darlene Barber were sworn in by President Pulia at the May 26<sup>th</sup> Board meeting.

Terms will expire April 2017

- C. Façade grant Application for 10439 & 10447 Cermak Road discussed. The EDC recommends approval fo the façade improvement grant application for these addresses for Dr. Kinnas with the following conditions:
- 1. The items noted in the inspection report dated May 14<sup>th</sup>, 2015 to be corrected.
- 2. If funding is requested for signage & landscaping, that plans be submitted for staff review prior to being placed on the Village board agenda for approval.

In recommending the application, the committee has determined that these improvements will support the goal of the program to encourage rehabilitation and preservation of commercial property; encourage new business; and retain, revitalize and expand existing business in Westchester.

The motion to approve was made by Lori-Jo Fergle, seconded by Bruce Horek. The vote was unanimous to approve.

D. Façade grant application for 10555 Cermak Road was waived until the next meeting of the EDC.

**6. Updates from Village Management-** Melissa Headley's report given, which included the Planning commission hearing for June 29<sup>th</sup>; the meeting of the Zoning committee on May 27<sup>th</sup> of the concepts report from the consulting company; and upcoming discussing with the Village Board of health requirements for outdoor food service of grilling, etc.
