- Food Vendor Fee: \$175 per event day
- Fees are waived for businesses located in Westchester or members of the Westchester Chamber of Commerce.
- All applications, documents, and payments are due by May 30, 2025.

Indemnification Agreement

The undersigned Vendor agrees to indemnify, defend, and hold harmless the Village of Westchester, its officers, agents, employees, and volunteers, and the Park District of Westchester, including its board members, employees, and agents, from and against any and all claims, liabilities, losses, damages, expenses, costs (including attorney's fees and court costs), and charges of any kind that arise out of or are in any way connected with the Vendor's operations or presence at the aforementioned events. This indemnification includes, but is not limited to, responsibility for all bodily injuries, death, and property damage sustained by any person or entity, including the attendees, other vendors, and the general public. This clause shall survive the expiration or termination of this agreement. The Vendor acknowledges that they have the sole responsibility to maintain adequate insurance coverage to meet these obligations and agrees to provide proof of such insurance upon request by the Village of Westchester or the Park District of Westchester.

Important Notes and Terms

All applications are subject to approval by the Village of Westchester. Space is limited and vendors may be selected to ensure a variety of offerings. The Village reserves the right to adjust or limit menu offerings to avoid duplication. If your application is approved, you must submit the required fee, insurance, and food safety documentation and pass an on-site health inspection. Failure to comply with any requirements will not constitute grounds for a registration fee refund. Vendors must arrive at least one hour prior to event start time and be fully set up. All vendors must be self-sufficient and responsible for their own setup, power, and operations.
