WPD Officers were dispatched to the area of Balmoral Avenue and Kent Street following a report of reckless driving involving a firearm. Upon locating the suspect vehicle, officers—assisted by neighboring law enforcement agencies—conducted a traffic stop leading to the arrest of a 37-year-old male from Cicero. The individual was taken into custody without incident and has been charged with Aggravated Unlawful Possession of a Weapon and Aggravated Assault with a Deadly Weapon. Fortunately, no injuries were reported during the incident.

The 37- year old was transported to Maybrook Courthouse for a bond hearing. The investigation remains ongoing.
