- a. Community Solar Energy Sovereignty and Equitable Energy Future Grants - The Building department had not heard about permits or plans.
 - b. Buckthorn Grant – Pre-meeting was set.
 - c. Onboarding for new members – Evie will do in a week. Annie will discuss emails. They have been added to the website.
8. **Old Business (70 min)**
- a. **Greenest Region Compact (GRC) and Subcommittee Updates – Liz W-Chase (20 min)**
- a. Overview and process: The Village signed on in 2015 when there was an environmental sustainability commission that was eventually disbanded. There are 10 sections; we are currently looking at the areas listed below. The GRC was devised by the Metropolitan Mayor's Caucus as a tool and guide for what municipalities can do.
 - b. Subcommittee reports:
 - i. Water – Mariana Nicolae/Walt
 - ii. Municipal Operations – Kari/ (open) - Demetrius volunteers
 - iii. Climate – Kari/(open) - Alex volunteers
 - iv. Energy – Liz/Walt
 - 1. Energy block grant may be used to guide future actions.
 - 2. E2 - Energy Audits – interested in pursuing engagement with local businesses
 - 3. E7 - Streetlights – conversion to LEDs is underway, we should be able to get info on percent completion
 - 4. E13 – Renewable energy technologies – have provided 2 years of solar presentations with CUB presenter, Marina Minic, to residents. Village had vetted the Municipal Mayors Caucus' Community Solar Clearinghouse solution (CS2) and residents may sign up. Liz has proposed an event where someone through the Mayor's Caucus will provide speakers on the CS2 initiative and energy efficiency. Marina Minic will also be returning to provide residents with solar education.
 - 5. E13 - Asked Building Dept for additional data on cumulative solar installations, currently have data from 2018 – Nov' 2023 to show growth in adoption of rooftop solar.
 - 6. E13 - Adopt – no difficulties with permitting process, the building department advised on timing for solar installs on new roofs. GROW would develop a flyer to share with entities that install a new roof.
 - 7. E14 - Procure renewable energy – municipalities may have multiple electrical accounts, smaller account might sign up for CS2
 - 8. E18 - Power down equipment – practiced in the office.
 - 9. Discussed adding form to google drive to ensure there is one copy.

Comments:

Evie suggests if we are submitting an actionable item, highlight it.
Liz noted that the climate section of the GRC has target reductions, Westchester has metrics from CMAP from 2019, there will be a new study in 2025.

b. West Cook Bicycle and Pedestrian Plan - Liz (5 minutes)

- a. Advisory committee meeting attended by Lee Kaufman and Liz. Liz shared a draft of the “Low Stress Bike Network.” May be a ten-year process to complete. Goal will be to connect communities, identify safety barriers. The consultant group has done this work in many communities, large scale and small scale and engage a lot of stakeholders.

c. SBC Stipends Fiscal Years Ending (FYE) 4/25 and 4/26– Nikki (10 minutes)

- a. Overview & review of FYE 4/25 approved projects
We are awaiting delivery of approved items. Collaboration on Water and Compost storyboard content is underway and will be submitted for printing ASAP.
- b. Discussed proposal template. We will be using this template for project consideration. Some projects may require planning further in advance (FYE 4/27 vs.FYE 4/26) to ensure ample time for resident engagement.
- c. During our May meeting, we will discuss proposals for consideration. Newly seated commissioners will be able to submit proposals during the June meeting. Please complete your forms and send them to Nikki and Liz.

9. Comments (5 min)

- i. Commission Comments
 - 1. Notes from Alliance for Water Efficiency Webinar (Mariana)
 - a. Federal Policy Updates – budget cut by 65%, 25 Executive Orders related to water, air, soil in first two months. Wind blows from West to East, air quality concerns, and soil concerns. EPA had 20 chemicals they are testing every day; two procedures on how to test for forever chemicals were cut immediately. Asks to tell family and friends about this. Filters for fridge – NSF Standard 53 takes lead and mercury out.
 - 2. Mariana mentioned an organization planning a lobbying trip to Springfield for climate action on May 21st.
 - 3. Kari mentioned an organization planning a lobby day on April 9th.

4. Liz – One Earth Film Fest is April 22 – 28; Bike Rodeo at Westchester Intermediate School – April 26; Salt Creek Watershed and Go Green LaGrange have cleanup events and would like to collaborate.
5. Walt – Do a town hall at coffee place and have people ask us questions. One Saturday for EVs or solar panels.

- Nicole Molinaro – Proud of GROW; “Finding the Mother Tree” is a good book about trees. Can’t find information on fee schedule for SBC for composting – can we unbury it? Stormwater mitigation – utility fee that Western Springs.
- LeeAnn Kruszynski – Would we consider releasing the GRC and the Village’s progress? It will be included in GROWs quarterly reports. Kari will include 10 min about GRC in climate talk; excited to see Pale Blue Dot is the contractor for Energy Block Grant and said she could help with the engagement; CMAP greenhouse gas emissions accounting will be included in energy plan; love idea of flyer for solar for new roofs and thought it would be cool to distribute to anyone with roof permit; shoutout to West Cook Wild Ones has similar Conservation @ Home program to increase habitat and help animals move – thinks its more accessible than conservation at home, it’s a free program and more of a pledge than a process. Liz mentioned that there’s an event on that topic on April 17th at Linda Francis Sokol Library in Brookfield
