- c. GRC Subcommittees Resident Participation and Process
 - i. AC- Residents may participate on subcommittees; what would the structure look like – does the commission want a townhall style or smaller groups with continuity of participation?
 - 1. Liz Wiseman-Chase (EWC)- The 2 commissioners on each GRC topic will define agenda for each meeting of subcommittee and predefine scope of discussion. ES- Are we recruiting volunteers (as is done with events)? Is this more of a townhall? EWC- each meeting would have predefined number of residents depending on the agenda. LAKcombination approach? Initial townhall for people to come and learn, introduce the topic, and provide a mechanism for feedback for as large a group as possible, followed by smaller subcommittee meetings that residents could engage with for their aligned interests MN- agree, townhall could introduce scope of GRC and subcommittees, should be advertised in newsletter; ES- maybe it's an opportunity to have a GROW event to engage more of the community WW- don't re-create the wheel, would like to interview other communities and learn how they have enacted changes, EWC- subcommittees should review preliminary GRC scoring and narrow down recommendations prior to engaging residents ES- Protocol must be followed when engaging with other communities; would require Village Manager approval EWCstart meeting as subcommittee groups of 2 commissioners to evaluate initial scoring and discuss more about topic scopes/processes

d. Recruitment - Update

i. AC put together a flyer; will be posted as soon as it is approved by commission; Letter of Interest (LOI) and resumes will be sent to ES, which will be compiled and passed along to the group for review; then interviews can be called. EWC mentions that the term "advisement" should be included in verbiage per the ordinance. ES- commission needs to review interview questions, could be quick special meeting or closed session. KR- unlikely that body would be ready to interview prior to 2/6; could wait and do exec session during feb meeting. All agree. ES- look at questions and email EWC and LK with questions; discussion will happen at Feb GROW regular meeting (exec session)

H. Old Business (40 min)

- a. GRC Subcommittee Interests (15 min)
 - a. EWC- Climate topic still needs to be covered, LK and KR will take this on. ES-let AC and ES know when subcommittee meetings will be held, they would like to attend if possible. This will enable admin input at the beginning of the process to ensure strategies/recomendations are viable. When each subcommittee has charted a preliminary path forward, they could possibly move forward w gaining input from other communities pending Village Manager approval.

b. Events

- i. December event debriefs (5 min) None
- ii. Upcoming event support needs (5 min)

- 1. Climate Movie Night 1/23/25 WW all going according to plan; got some positive feedback on the concept from staff
- 2. LK- bicycle rodeo with park district and schools at intermediate school ES_ why did it move from GROW LK- so that the Village doesn't need to commit its resources. Event will have courses to ride through, bike checks and maintenance, rules of the road, etc. ES- needs to be removed from GROW event agenda if it's not a Village event
- **3.** KR- any updates on waste removal event this spring? (Confusion about who was waiting on who) ES- will check emails
- **4.** EWC- will be reaching out to CUB for spring solar event, would like them to talk about group buy, IL solar for all, solar farm offers, someone from MC2 to speak or MMC to make more holistic solar event
- 5. WW- Climate change update event. KR is certified through Climate Reality Group, is willing to present, there are a range of topics to choose from
- c. Newsletter article ideas/support (5 min)
 - iii. February "Eco-Friendly Valentine's Day" Walt 3 min.
 - 1. WW- sent article and Green Fact for the month ES- would like to see Green Fact separated with box or on top to highlight it, focus on something that people can do something EWC fact should focus on empowerment WW- will send out a list and cmrs can prioritize and add to the list as commissioners find new facts

iv. March

 MN -International Water Day is March 22, she will write an article ES- possible Green Fact related to compost or SBC organics program (begins again from April 1- December 31) EWCassociated proclamation for Int'l Water Day? MN will review

9. New Business (20 min)

- i. 2025 Goals Liz (10 min)
 - 1. EWC- Should we continue this individual format or identify a few key themes and make it collective; LAK suggests collective and overarching goals to drive home what GROW is working on rather than individual priorities; KR suggests that would also preserve continuity as cmrs step down/change. ES- Education and engagement should remain, KR suggests that CAP may overlap with GRC and EWC suggests that the goals should be Education/Engagement and CAP for now; list will be updated as GRC subcommittees meet and decide upon topic goals
- ii. Use of stipend from SBC (\$2000 per year for the life of SBC contract; fiscal year ends in April) Liz (10 min)
 - 1. Previous ideas included engagement materials; rain barrels; native seeds; OneEarth
 - a. EWC do the funds roll over? AC- needs to be used in the fiscal year; unclear whether goods need to be received or whether being under contract counts as "spending" funds

- EWC- Previous ideas included plant seeds as giveaway item for native seed propagation/plant scapes for lawn events; rain barrels and demonstration project paired with water conservation demonstration; similar idea for composting and story board; induction cooktop/air monitor for air quality event
- c. WW- wind turbine for the building, annual funding
- d. LK- bike racks
- e. WW- water filters for Pb in water? ES- Village is already doing that, include cost of staff
- f. EWC- come up with proposals for discussion at Feb meeting ES- send ideas with some context to EWC and LAK to be narrowed down and voted upon in Feb; ES will get clarity on whether goods need to be received by 4/30

10. Comments (5 min)

- i. Commission Comments
 - EWC has December 2024 EV report, 135 EVs in Westchester, over 122,175 in IL. LK asked how many EV stations are in IL EWC- unknown; data came from IL Secretary of State
- ii. Staff/Board Comments
 - Prior to meeting, AC sent notes re: Village compliance efforts on lead in drinking water, MN- link to memo within AC's notes; where are memoranda located on website? AC- they are in the Board meeting agendas/packets and e-news ES- Board meetings and agendas are useful sources of info and can be used to answer questions and help cmrs. Stay informed.
- 11. Public Participation In order to give as many visitors as possible an opportunity to speak and in the interest of adjourning the meeting by 8:00 p.m., please limit your comments to 3 minutes in length, unless further time is granted by the Commission.

Resident Alex Silva – Teacher. Suggested that rather than focusing on curriculum and content delivery, GROW's efforts might be most useful in helping schools to access equipment that provides a touchpoint to environmental science. Ex. If there was extra funding in the budget, GROW could purchase an air quality monitor and loan it out to under-resourced schools for their use in science classes.
