# MEETING MINUTES FIRE AND POLICE COMMISSION MEETING July 6, 2015

#### **CALL TO ORDER:**

The meeting was called to order at 6:10pm and followed by the Pledge of Allegiance. Responding present to roll call were Commissioner Brian Kuratko and Commissioner Thomas McCarthy. Commission Chairperson Gudino was absent. Also present were Village Manager Janet Mathys, Board Attorney Michael Jurusik, and Management Assistant Mary Detente. Fire Chief Adams arrived at 6:25pm. Commissioner McCarthy was asked to Chair the meeting in the absence of the Chairperson.

#### APPROVAL OF MINUTES:

Commissioner McCarthy entertained a motion to approve a Resolution approving the content of and/or release of certain executive session meeting minutes of the Board of Fire and Police Commission.
